## **Energy Companies accelerate speed of development of COOL LPG Technology**

## Stuttgart (Germany), Chicago IL (United States)

On February 7<sup>th</sup> - 8<sup>th</sup>, 2023, the Chief Executive Officers of Green LG Energy S.r.I, Friedrich Scharr KG, rLPG North America, BioLPG LLC and GTI Energy met at GTI Energy headquarters outside Chicago, Illinois to plan intensification and acceleration of their collaborative development of the GTI Energy renewable LPG production technology, Cool LPG.

The Cool LPG process will provide economically viable, renewably sourced from biogenic waste LPG, offering full drop-in compatibility with existing global LPG infrastructure, while delivering emissions reductions needed to progress the green transition.

Green LG Energy S.r.I, a strategic joint venture focused on development of new technologies for production and distribution of LPG derived from renewable sources, was established on 6 July 2022 in Milan. Its founding partners are Italian LPG sector leaders AGN ENERGIA, Beyfin, Gruppo Cavagna, Gruppo Socogas and Veroniki Holding/Butangas.
