If a substance listed in Appendix 13 also falls within one or more of points (a) to (g) of paragraph 1, the concentration limit laid down in point (h) of paragraph 1 shall apply to that substance.
4. By way of derogation, paragraph 1 shall not apply to the following substances until 4 January 2023:
- (a) Pigment Blue 15:3 (CI 74160, EC No 205-685-1, CAS No 147-14-8);
 - (b) Pigment Green 7 (CI 74260, EC No 215-524-7, CAS No 1328-53-6).
5. If the name of a substance, used as ingredient within the meaning of this entry, is already required to be stated on the label in accordance with Regulation (EC) No 1272/2008, that ingredient does not need to be marked in accordance with this Regulation;
 - (d) the additional statement "pH regulator" for substances falling under point (d)(i) of paragraph 1;
